AGMA	-	"3.0 Travelling Showpeople (Policy L7) 3.1 The GM GTAA focussed solely on need for Travelling Showpeople within the sub-region and identified a number of critical issues including the size and numbers of pitches currently provided. However, given the sample size and the fact that the study was only based on the sub-region, the GM GTAA was unable to take account of the preferences of Travelling Showpeople. 3.2 Therefore, whilst the GM GTAA forms an important part of the evidence base, this work needs to be considered alongside other areas of research, including the work carried out by the Showmen’s Guild Lancashire and Cheshire Sections – The North West’s Travelling Showpeople’s Current Base Location, Preferred Base Locations and Operating Patterns. This study identified the preferences of Travelling Showpeople across the North West, which 4NW has taken account of in the Draft Policy L7."

AGMA	-	<p>"Regional Distribution 3.3</p> <p>AGMA broadly supports the need to address the preferences of Travelling Showpeople because of the need to locate Showpeople in areas where they apply most of their trade and to try and achieve a more equitable distribution of sites across the region.</p> <p>At the moment, GM currently has 72% (see Table 4) of the Region's total provision for Travelling Showpeople but the evidence in the research provided by the Showmen's Guild suggests that a considerable amount of their trade is applied outside of GM throughout the year. Therefore, the Partial Review of RSS provides an opportunity to achieve a more equitable regional distribution of provision for Travelling Showpeople outside of GM, which also meets their needs. Whilst this is less than the current percentage of 72%, AGMA considers that the proposed distribution could be more evenly distributed throughout the region. Merseyside, for example, has no provision at present and would only have 1% of the total regional provision by 2016 under the current Draft Policy, despite having similar links to the region's motorway networks and being of a similar size and area to GM.</p> <p>3.5 Therefore, although the Draft Policy does try to redistribute some of the new provision for Travelling Showpeople away from the GM sub-region, AGMA suggests that 4NW should consider an even greater distribution of requirements to provide a more even spread of provision across the region over the longer term. 		<p>Distribution</p> <p>3.6 It has become clear that there will need to be some redistribution of the pitch requirements within the GM sub-region from the discussions that have taken place at the workshops. At the moment four districts within GM have no provision but AGMA accepts that these may need to provide some level of provision to meet the needs and preferences of the Travelling Showpeople.</p> <p>3.7 However, AGMA does have some concerns as to whether the proposed pitch provisions in some districts within GM will be utilised, where there is no direct evidence of need. This concern is particularly applicable to Stockport, where the GM GTAA and Draft Policy currently indicate no pitch requirements. It has been suggested that Stockport may need to provide for 20 pitches in the light of the evidence on preferences supplied by the Travelling Showpeople. Stockport have indicated that an initial requirement of 10 pitches would be more appropriate to facilitate the geographical spread within the sub-region but allow true demand over the longer term to be determined in the next review of RSS. AGMA reserves the right to comment on any revised pitch requirements for Travelling Showpeople in the next stage of consultation."</p>

AGMA	<p>4.3 AGMA also has significant concerns about the delivery of the proposed policy requirements and the implications that this may have for the progress of LDFs. In particular, there are capacity and policy constraints, and issues of sequence of delivery, that will need to be considered by LPA's as they take their LDF's forward and these concerns need to be considered by 4NW when the proposed policy is revised to reflect concerns raised by those making representations.</p> <p>4.4 In terms of Policy L7 (Travelling Showpeople), AGMA broadly supports the aim of having a more equitable distribution of provision across the region and within sub-regions. However, although 4NW have tried to redistribute some of the need out of GM to other sub-regions, it is felt that the Partial Review provides an opportunity to do more. It is clear that there are other sub-regions that have little or no provision currently and are unlikely to have any significant share by 2016 under the current drafting of the Policy.</p>

		<p>available. The Policy seeks to address where people currently live and would like to live – also having regard to locations where previously little provision is made, but where fairground sites and their work is currently located.</p> <p>It is understood that the consultation with the Showmans Guild members has informed the process, but the information provided only shows broadly in which LPAS there is any need. It provides no detail of the precise numbers of fairs and their distribution across the Region. In these terms, for example, Blackpool Council is aware there are 16 fairs in the Fylde Sub-Region, only 2 of which take place in Blackpool. It is not known how this compares with the incidence of fairs elsewhere across the NW Region. Nevertheless, it is accepted that some increased provision is needed in the Fylde Sub-Region. Whether it is of the scale proposed, which represents a major increase from the earlier Lancashire GTAA Survey (which only identified the need for 3 additional TSP plots for the Fylde Sub-Region – as against 30 now required by draft Policy L7) or a significantly lower figure is questioned. Equally, the evidence for an equal split of required provision across the Fylde Sub-Region is unclear – both in relation to the incidence of fairs (only 2 of 16 in Blackpool) and, in Blackpool’s terms, its acute shortage of land and already high level of existing provision of the separate, but still similar requirements for Gypsy and Traveller sites.</p>

It is understood that the figures consulted upon before Christmas took account of the report produced by the Showmen’s Guild. This report identified 3 plots for Cheshire West &amp; Chester for Travelling Showpeople although the GTAA identified 4 plots. The figures now consulted upon are for 10 plots. It would be helpful to demonstrate how the final figure for the authority was arrived at to enable an informed response (it is noted that the Showman’s Guild state that plots need to be at least 5 pitches).</p> <p>Consultation with the G&amp;T Co-ordinator for the Cheshire sub-regional partnership has indicated that a higher figure than that in the GTAA for Cheshire could be justified, however the Council would still like to see the reasoning behind the suggested figure.</p>

		<p>annual 3% compound increase in the level of overall plot provision. This will mean that a further 2 plots are needed in Chorley, which when future proofed will rise to 5 plots. Therefore, 15 plots in total will be required in the Borough up until 2021.</p> <p>3. Chorley Council rejects the level of plot provision proposed on the basis that more evidence needs to be provided by 4NW and the Showmen's Guild about the need for pitches in the Borough ( additional information has been requested by Lancashire authorities). The proposed plot provision seems to be based on a preference by a small percentage of Travelling Showpeople to be located in the Central Lancashire area (including Chorley) , as it will assist their travelling patterns and a requirement by 4NW to spread the plot distribution around Lancashire.</p> <p>4. The Lancashire GTAA07 indicated a requirement for 9 additional pitches in Lancashire between 2006 and 2016, but did not find a requirement for any pitches in Chorley. The Interim draft RSS policy initially required 14 plots in Chorley Borough, which has risen to 15 plots in the draft RSS policy, when future proofing is taken into account . This level of provision is astonishing when compared with the Lancashire GTAA suggested requirement of 0 plots.</p> <p>5. 4NW state that the methodology for Travelling Showpeople plots was never driven by the GTAA and that this evidence was just a starting point and the option now suggested is a more equitable distribution that supports the needs of Travelling Showpeople. They also highlight that the GTAA failed to ask about overcrowding and doubling up. However, there appears to be very little evidence to support this position.</p> <p>6. A survey of Travelling Showpeople produced for the North West by 4NW with assistance from the Showmens Guild provides little evidence of need, but simply suggests that every one of the 41 authorities in the North West should set aside 1 acre for 10 plots , which would sort out all requirements. A further study ' The North West's Travelling Showpeople's Current Base Location, Preferred Base Locations and Operating Patterns' 4NW, 2008 is based on data collected in the Showmen's Guild Travelling Preference Survey (Autumn 2007). this study identified that there are small proportions of Travelling Showpeople based in Chorley Borough. 3.1% to 6% location (multiple) show the same percentage preference. The report indicates in its comparison of current base to preferred base that Travelling Showpeople operating in the NW would ideally like to be based in Bolton or Preston. Chorley is not identified. The report also found that no operating patterns wer identified in Chorley during Dec 2006- Oct 2007 for Travelling Showpeople. The Report does conclude that there is a definite need for a</p>

		<p>wider breadth of provision across the region. Travelling Showpeople say that they need to be located in more suitable locations to reflect their travelling patterns and that overcrowding on existing sites and doubling up leads to unacceptable conditions. Geographically central locations are favoured with good motorway links, but a judgement is still required on locations. There is little hard evidence to support that level of provision proposed in Chorley Borough.</p> <p>To conclude, in the absence of clear evidence of substantial need, Chorley Council objects to the high proposed allocation of plots for Travelling Showpeople in Chorley Borough.</p>

LAs could do this if necessary without being told in RSS that they can, and shouldn't be encouraged to do so unless there is no other option. Para 11 provides sufficient guidance. Otherwise GB policy may be seen to be undermined.</p> <p>The policy as it stands actively promotes considering the provision of sites in the Green Belt, whereas para 11 much more closely reflects the provisions of RDF4 and PPG2. Either the reference to Green Belt in the policy should be removed, or replaced with the following sentences from para 11: "All other alternatives should be explored before Green Belt locations are considered. If there is an identified need for a Gypsy and Traveller site in an area and no suitable sites outside the Green Belt boundary exist, in exceptional circumstances, limited alterations or sites inset in the Green Belt could be considered. It is, for example, not clear whether the annual 3% compound increase to be applied post-2016 will be applied pro-rata at district level, irrespective of local need or demand. The requirement for new major developments to include provision for travelling showpeople is unduly restrictive and poorly defined in terms of the types of land use or development being considered and appears contrary to the intention to identify sites through Local Development Frameworks. The Policy text with regard to sites in the Green Belt should better reflect the comments provided in the supporting text, which make it clear that this option should be a last resort, in exceptional circumstances, where all other alternatives have been exhausted. While the text on the possibility of redistributing provision through the preparation of joint or co-ordinated Local Development Documents is welcome, the implications of a “co-ordinated” approach should be clarified in the supporting text for the avoidance of doubt.</p>
